- Applicants are required to furnish **original documents** along with one set of self-attested photocopies of the same at the Passport Seva Kendra (PSK) for processing.
- **Applicants over the age of 18 years** have to submit any **three of the documents** specified in the below-mentioned **List of Acceptable Documents**, plus **address and non-ECR proofs** as applicable.
- **Applicants below the age of 18 years** have to submit any **two of the documents** from Serial numbers 1 to 6 specified in the below-mentioned **List of Acceptable Documents**, plus **address and non-ECR proofs** as applicable.

A. List of Acceptable Documents: Please select only 3 documents in case of applicants over the age of 18 years and 2 documents in case of applicants below the age of 18 years. Please ensure that the details mentioned (such as complete name, Date of Birth, Father's name etc) are the same in all the documents. However, address is not mandatorily required to be same in all the documents submitted by the applicants, but at least one of these documents should match the address filled in the application form.
